<b>PROGRAM AIM</b>	<p>The Juvenile Court Diversion Program (JCC) is a voluntary restorative justice alternative to formal court proceedings in the 8<sup>th</sup> Circuit Court-Keene District for juveniles who have committed a chargeable first offense. It is the goal of JCC to minimize a young person's involvement in the justice system and to encourage a sense of responsibility and accountability on the part of youth for their illegal acts. JCC considers each case individually and strives to address the needs of the juveniles, victims, and the community.</p> <p>Other resources created by this program include the Youth Intervention Program, Earn-It, and Summer Youth Employment.</p>
