We work with clients and their families in a supportive and respectful setting to provide the opportunity for the individual to repair the harm done and reduce likelihood of re-offending. We have community resources and partnerships with local law enforcement. Through the restorative process participants explore the impact their actions had on the impact their actions had on themselves, the community, and identified harmed parties.</p> <p>Successful completion of our restorative justice-based court diversion program frees an individual from further court action and dismisses his/her charge. Our program helps the participant repair the harm done to the victim, their family, themselves and the community.</p>
