PROGRAM AIM	<p>The Seacoast Community Diversion Program (SCDP) of The Chase Home is an early intervention program that diverts youth between the ages of 13 & 18 who have committed a chargeable offense from the traditional juvenile justice system (and probation). Every participant is required to complete a contract that is tailored to their circumstance and needs. Contract requirements incorporate restorative justice principles such as community service, harmed party reparation, and building healthy relationships. The SCDP assists with providing additional support and connections for participants and their families within the community as needed. The primary goals for diversion youth are to hold youth accountable for delinquent behaviors, make amends, and empower them to improve their behavior and personal growth through education and support service so they do not end up in the NH Juvenile Court.</p>
